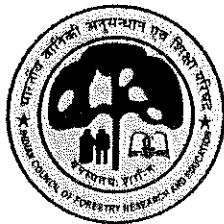

**ORDER**


Research communication is a two way process, the IFS officers are vital link between linking research/scientists and management practices in the field for forest conservation/development and forest based livelihoods. The work of the ICFRE scientists/professionals needs to be transferred to the field to meet the emerging challenges of climate change, forests and water security and biodiversity conservation. The existing requirement is to enhance the outreach of research findings so that the extension of research makes immediate impact of research in the field.

2. The Director General, ICFRE is therefore pleased to approve a Scheme "Direct to Consumers" for immediate transfer of recently developed technologies to the Consumers, i.e., Forest Departments, Farmers, Industries and other Stakeholders. For this purpose, a Committee, for each such project, consisting of following members is constituted to implement the Research Project. Each ADG will head a team to implement the scheme for a bunch of technologies/technology.

1. Team Leader - ADG of ICFRE
2. Project Investigator of the Research Project
3. One Scientist of the concerned Division to be nominated by the DDG (Research)

2. The DG, ICFRE will hold a meeting on 08<sup>th</sup> July 2011 at 11.00 A.M. to launch the said scheme. Before this DDG (Research) and DDG (Extension) may take a meeting of all the ADGs of ICFRE.

3. The DG, ICFRE is further pleased to make a tentative provision of Rs. Ten Lakh, only out of the existing Research Budget.
