Subject : Notice Inviting Expression of Interest (EoI) for hiring the services of junior consultant for assisting the ARCBR in implementation of REDD+ pilot project in Mizoram

The Indian Council of Forestry Research and Education (ICFRE) Dehradun and its Advanced Research Centre for Bamboo and Rattan (ARCBR) Aizawl in collaboration with International Centre for Integrated Mountain Development (ICIMOD), Kathmandu (Nepal) is implementing a Trans Boundary REDD+ Capacity Building Pilot Project in Mizoram.

In this connection, the ARCBR intends to hire a qualified junior consultant professionally competent for assisting the project team in the implementation of Project : "REDD+ Himalayas: Developing and using experience in implementing REDD in the Himalayas". The expertise expected from the consultant will be in the field of Forestry; including carbon stock estimation, identifying the drivers of deforestation & forest degradation and working towards harmonization in the region, exchange experience and mutual learning on good REDD-plus implementation practices.

The ARCBR invites Expression of Interest (EoI) from individuals who possess required expertise and qualification in the relevant field.

Mere submission of EoI will not confer to applicants any right for receiving or carrying out the tendered job. The ARCBR reserves the right to accept/reject one or all EoIs or stop the process of approval at any stage, at its sole discretion without assigning any reasons and shall bear no liability whatsoever consequent upon such a decision.

Details of TOR indicating the assignment, eligibility, selection criteria and mode of submission of documents are as given below:

1. BACKGROUND:

In consideration of the roles and responsibilities of the Advanced Research Centre for Bamboo & Rattan (ARCBR), Mizoram as an executing agency of the REDD+ Pilot Project, the ARCBR, Mizoram intends to employ a professionally competent junior consultant to assist in the implementation of Project.

2. OBJECTIVE OF THE CONSULTING SERVICES:

The objective of the consulting services is to provide the ARCBR with managerial and technical assistance related to overall implementation of the Project.

3. SCOPE OF WORK:

- 1. Assisting ARCBR to formulate a plan of operation for the implementation of the project.
- 2. Assisting ARCBR to pursue effective and efficient project management.

3.1 Detailed scope of work :

- (1) To assist in field works for data collection and conduct of meetings with villagers,
- (2) To assist ARCBR in conduct of training/workshop/seminar/consultative meeting;
- (3) To feed data in computer from relevant questionnaires of PRA exercise, etc.
- (4) To undertake any other work as assigned by the ARCBR

3.2 Expected outputs :

- (1) Field data collection and accomplishment of project works in stipulated time.
- (2) Assessment of carbon stock and development of biomass equations for bamboo
- (3) Assistance in planning and conduct of training programmes
- (4) Assistance in organization of workshop/seminar/consultative meetings

3.3 Project staff to be engaged :

Junior Consultant

The junior consultant of required qualification and expertise shall be recruited by the ARCBR.

3.4 Required Qualification :

Essential: First class M. Sc. in Forestry, Environmental science, Botany, Agriculture or allied sciences.

Desirable:

- Knowledge and experience in carbon stock estimation with forestry based socioeconomic survey and statistics
- Good command of English
- Working knowledge of local language
- Computer skills

3.5 Expected period of duration :

Twelve months but is subject to change.

3.6 Remuneration :

Rs. 20,000/- (Rupees twenty thousand) only per month plus HRA @ 10%

5. SELECTION PROCEDURE AND CRITERIA :

Applicant will be selected in two stages.

Stage One is to check whether applicant is basically fit for the assignment while the **Stage Two** is to select most promising candidate among those who pass the Stage One test. The applicant should have core competent skilled manpower as well as required qualification in providing consulting services for activities related to the Project.

5.1 Stage One: Pass or Fail Test

1) Pass-or-Fail Test with respect to -

- Requisite qualification;
- Relevant expertise;
- Age limit;

2) Criteria -

- Qualification certificates and experience to provide consulting services in the Related Field Projects* yes or no
- Previous experience if any, in relevant field yes or no
- Age proof certificate yes or no

5.2 Stage Two: Ranking for short-listing :

Ranking of the applicants which have passed the Stage One test is to be made for shortlisting purpose by assessing percentage in requisite qualification and any area of expertise described in clause "3.4 Qualifications Required for areas of expertise" in Section 3 above.

Weights will also be given according to the level of qualifications of experts assigned to the projects. Weight 1.0 will be accorded to those experts who are in the required area of expertise and meet the qualifications, and weight 0.5 to those who are in the required area of expertise but their qualifications are not up to the described requirements. A cap of 2/3 is applicable for the sum of weighted person/month of any single area of expertise in the total weighted person/month of an applicant. An applicant with the highest count is ranked first and the other applicants are ranked in the decreasing order of the respective counts. The highest ranked applicant will be selected and invited for submission of acceptance of offer. An interview may also be conducted in-case of selection of more than one candidate in the above stages.

*Related Field Projects are defined as:

(a) Either forestry based projects or projects related to the participatory management of publicly used natural resources;

6. **OTHERS** :

6.1 Standard of ethics :

ARCBR requires that consultant under contracts funded with ICIMOD, ICFRE, MoEFCC and other international organizations, observes the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, ARCBR;

(1) will recognize a consultant as ineligible to be awarded a contract if it determines that the consultant has engaged in corrupt or fraudulent practices in competing for the contract in question;

(2) will recognize a consultant as ineligible, for a period determined by ARCBR, to be awarded a contract if it at any times determines that the consultant has engaged in corrupt or fraudulent practices in competing for, or in executing another contract.

6.2 Conflict of interest :

(1) An individual/firm hired to provide consulting services for this assignment, and each of its affiliates, shall be disqualified from subsequently providing for the Project goods, works or any other service related to this assignment other than a continuation of the "Services" under the ongoing contract.

(2) Neither consultant nor any of their affiliates shall be hired for any assignment that, by its nature, may be in conflict with another assignment of the consultant.

(3) Consultant that has a business or family relationship with such member(s) of the Project team who are directly or indirectly involved in any part of; (i) the preparation of the ToR of the contract, (ii) the selection process for such contract, or (iii) supervision of such contract; may not be awarded a contract unless it is established to the complete satisfaction of the RFRI/ARCBR, for the reason to be recorded in writing, that such relationship would not affect the aspects of fairness and transparency in the selection process and monitoring of consultant's work.
