CIRCULAR

The Indian Council of Forestry Research and Education is an Autonomous Council of the Ministry of Environment Forests & Climate Change, Government of India, with its Institutes at Dehradun, Jabalpur, Bangalore, Jorhat, Jodhpur, Coimbatore, Shimla, Ranchi, and Hyderabad.

The following posts in the ICFRE's Institutes and its centres are available for filling up on deputation basis at the level of Conservator of Forests (CF) from IFS officers in the pay scale of PB-4 and Deputy Conservator of Forests (DCF) from IFS/SFS officers in the pay scale of PB-4 and PB-3. IFS officers who are already working in pay scale of PB-4 with Grade pay of Rs.10,000/- may also apply for consideration to the post of Conservator of Forests and they will be eligible for pay protection as per rules.
