Terms & Conditions for the post of Deputy Ranger, IFGTB, Coimbatore-2

The Institute of Forest Genetics & Tree Breeding, Coimbatore-2 a constituent unit of ICFRE an Autonomous body under the Ministry of Environment & Forests, Government of India, invites applications from amongst the eligible candidates working under ICFRE/ All State Forest Departments for filling up of one post of Deputy Ranger on Deputation basis at the Institute of Forest Genetics & Tree Breeding, Coimbatore-2 in the Pay Band-1: Rs.5,200-20,200/- plus Grade Pay of Rs.2,400/-.

(A) Eligibility:

- (a) Officials holding analogous posts or having successfully completed training from Rangers College with more than three years experience from the State Forest Departments.
- (b) The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

(B) Tenure:

The tenure of deputation shall ordinarily be 3 years extendable upto 4 years or till superannuation, whichever is earlier. The tenure can, however, be curtailed or extended by the Competent Authority subject to the performance of the individual.
