## **Terms & conditions for the post of Deputy Ranger, IWST**

The Institute of Wood Science & Technology, Bangalore a constituent unit of ICFRE an Autonomous body under the Ministry of Environment & Forests, Government of India, invites applications from amongst the eligible candidates working under ICFRE / All State Forest Departments for filling up of one post of Deputy Ranger on deputation basis at the Institute of Wood Science & Technology, Bangalore in the Pay Band-1: Rs.5,200-20,200/- plus Grade Pay of Rs.2,400/-.

### **(A) Eligibility:**

- (a) Officials holding analogous posts or having successfully completed training from rangers college with more than three years experience from the State Forest Departments.
- (b) The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

### **(B) Tenure:**

The tenure of deputation shall ordinarily be of 2 years extendable upto 4 years or till superannuation, whichever is earlier. The tenure can, however, be curtailed or extended by the Competent Authority subject to the performance of the individual.
