The Indian Council of Forestry Research and Education (ICFRE, an Autonomous Body of the Ministry of Environment, Forests and Climate Change, Government of India invites applications from the eligible officers under Central/State/Public Sector Undertakings/ Autonomous Bodies/Statutory organization for filling up 13 (Thirteen) posts of Forest Range Officer on deputation including short terms contract basis in under mentioned Institutes of ICFRE in the Pay Scale at Level 7 of Pay Matrix plus usual allowances as admissible under rules in ICFRE:


The above vacancies may either be decreased or increased in any Institute subject to variation dependent on workload.

Eligibility: Forest Ranger/Dy. Ranger having successfully completed training from Ranger College, with more than three years experience from the State Forest Department.

Tenure: The tenure shall ordinarily be 3 years or till superannuation, whichever is earlier. The tenure is, however, liable to be terminable at an earlier date or extendable at the discretion of appointing authority/cadre controlling authority.

General Instructions:

1. Applications with complete bio-data together with a fee of Rs.500/- (Rupees Five hundred only) in the form of Demand Draft drawn in favour of **the Accounts Officer, ICFRE** should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun on or before **28.02.2018**.
2. The closing date of receipt of applications from candidates residing in Andaman & Nicobar Island and Lakshadweep will be **15.03.2019**.
3. Separate application should be submitted along with Demand Draft of Rs.500/- for each post if a candidate wishes to apply for more than one post.
4. Application and the envelope should be superscripted as "**Application for the post of Forest Range Officer**" against circular No.36-51/2018-ICFRE - FRO". Applications incomplete in any respect shall be summarily rejected.
5. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
6. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last five years (2013-14 to 2017-18) while forwarding the applications of the candidates. However, an advance copy can be submitted along with the prescribed fee.
7. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates
8. The Council reserves the right not to fill up the vacancy advertised if the circumstances so warrant in the interest of the Council.
9. Retired Forest Range Officer/Forest Ranger need not apply for appointment to the post of FRO as their candidature will not be considered.
