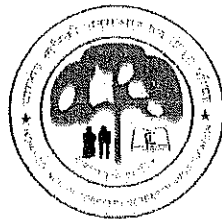

The eligibility conditions of the posts are indicated below:-

**(A) Eligibility and Education Qualification:-**

- i) Possessing the MBBS Degree.
- ii) Doctors of the CGHS/State Govt./Semi Govt. or Autonomous organization holding the post of Medical Officer on regular basis.

**(B) Terms and Conditions:-**

The terms of appointment will normally be for a period of three years which can be extended by the Competent Authority for another two years.

**(C) General Instructions:-**

1. Applications with complete bio-data together with a fee of Rs.200/-(Rupees Two hundred only) in the form of Demand Draft drawn in favour of **the Accounts Officer, ICFRE** should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. 3. Application and the envelope should be superscripted as "**Application for the post of Sr. Medical Officer/Medical Officer**" against Advt.No. 32-31/2017/Sr.M.O./M.O./ICFRE". Applications incomplete in any respect shall be summarily rejected.
4. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.

5. The candidate must submit their application through proper channel.
