**CIRCULAR**

**SUBJECT:** Empanelment of CGHS approved / empanelled Private Health Care Organisations (HCOs) with Indian Council of Forestry Research & Education (ICFRE). Procedure for obtaining medical treatment facilities and diagnostic procedures.

In accordance with the provision contained in para 3(h) of the MOA signed between CGHS and HCOs and in terms of recognition granted to the ICFRE by the Ministry of Health & Family Welfare conveyed vide Ministry of Environment, Forest and Climate change vide letter No.2-48/2011-FE dated 01.04.2015, the Competent Authority in ICFRE has notified 12 Private Health Care Organizations (HCOs) located at Dehra Dun annexed as Annexure-A as empanelled hospitals / diagnostic centers with ICFRE for providing medical treatment facilities / diagnostic procedures to the ICFRE's beneficiaries on cash basis on the same terms and conditions and prescribed rates / package rates as applicable under CGHS. All these notifications have been uploaded on the ICFRE website for information of all the beneficiaries.

It is further informed that the ICFRE / ICFREPHS beneficiaries can not go to these empanelled hospitals / diagnostic Centers directly except in emergent circumstances. **In other condition, the referral by the AMA / CMO, NHF is the mandatory requirement for reimbursement of the medical claim incurred on treatment in these hospitals by the beneficiaries.** The beneficiary must compulsorily carry his / her ICFREPHS Card / Identity Card / dependent proof at the time of registration at the empanelled hospitals to avoid any inconvenience to them.
