
In compliance of the orders of the MoEF&CC, the scientists working in ICFRE and its Institutes were ante-dated from their due dates on notional basis without any payment of arrears in accordance with MoEF O.M. No.09/12/2012-P.III, dated 24.05.2013. The scientists who became due for assessment after ante-dating alongwith fresh candidates due for review/assessment as on 01.07.2015 were considered by the Internal Screening Committee in its meeting held on 26.05.2015 and 27.05.2015. The instructions circulated vide this office circular dated 14.05.2015 read with Ministry's instructions dated 02.12.2014 were kept in view while considering the scientists for review/assessment to the next higher grade under FCS of ICFRE.
