More than three months have been elapsed but requisite declaration in respect of dependent family members of Pensioners of your Institute, as asked for therein, has not been received so far.

In this connection, it may please be brought to the notice of all Pensioners concerned that it is their responsibility to apply for deletion of name of dependent from the ICFREPHS eards when the ward is no more entitled to the benefits—under the scheme. The failure on the part of a card holder to get the name of a family member deleted from the ICFREPHS card when he is no more dependent on him/her, is a good and sufficient reason for initiating action against him/her in terms of rules/laws.

It is, therefore, requested that necessary declaration regarding employment, income, marriage & residence etc. in respect of their dependent children issued by the Comptent Authority may please be obtained from the Pensioners concerned. The genuineness and eligibility for continuance of their inclusion in the ICFREPHS may also be ensured before forwarding their declaration to this office.

Please refer to this office circular of even number dated 04-11-2013 and letter No.11-02/PHS/2014-ICFRE dated 06-01-2015 on the above mentioned subject. In this connection, it is stated that the conditions of eligibility of inclusion of parents, sons and daughter as dependent for availing medical facilities are as follows:-

- (v) Parents subject to the conditions of dependency and residence etc. being cetified.
- (vi) Son is eligible till be starts earning, or attain the age of 25 years or gets married whichever is earlier. Son suffering from permanent disability either physically or mentally without any age limit. Permanent disability means a person with 40% or more of one or more disability.
- (vii) Daughter is eligible till she starts earning or gets married, whichever is earlier (irrespective of age).
- (viii) Dependent divorced/abandoned or separated from their husband/widowed daughter (irrespective of age).

As per Ministry of Health & Family Welfare OM No. 5-11015/10/2011-CGHS(P), dated 19.07.2011, the income limit for the purpose of dependency will be: Members of family (other than spouse) whose income is less than Rs.3500/- p.m. (i.e. upto Rs.3.499/- p.m.) plus the amount of dearness relief thereon as on the date of consideration.

5. The pensioners are required to furnish declaration regarding the income, marriage and the residence etc. of dependant family members once in every calendar year for maintaining continuity of their inclusion as dependant for availing medical facilities. It has been noticed that the require annual declaration in respect of their dependant in this regard is not being submitted by the Pensioners concerned. The list of Pensioners and

their dependant family members (Annexure-I) availing medical facilities is sent, herewith, for information and necessary action.

- 6. The Pensioners concerned may, therefore, be asked to submit necessary declaration regarding employment, income, marriage and residence etc. issued by the Competent Authority in respect of their dependent family members by 31st March every year failing which further action for deletion of name of such dependent from their family members etc. will be initiated as per rules.
- 7. It is further requested that the guidelines regarding genuineness and eligibility of dependant family members contained in this office aforementioned circular dated 04-11-2013 and letter dated 06-01-2015 may please be adhered to before forwarding applications/declaration of Pensioners in the matter to this office.
