## Request for Quotations for Procurement of Agriculture Spray Pumps (ASPEE) for biopesticides application for productivity enhancement in the ESIP areas of Madhya Pradesh and Chhattisgarh (Through GeM)

- 1. The Government of India has received grant from the World Bank toward the cost of the Ecosystem Services Improvement Project (ESIP). Indian Council of Forestry Research and Education (ICFRE) is one of the Project Implementing Agencies and implementing one of the components of ESIP i.e. Scaling up of Sustainable Land and Ecosystem Management in Selected Landscapes, and intends to apply the part of proceeds of this grant to eligible payments under the contract for which this Request for Quotations is issued. The procurement process will be conducted in accordance with the shopping procurement method contained in the World Bank Guidelines: Procurement of Goods, Works and Non-consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers, dated January 2011, revised in July 2014.
- 2. ICFRE now invites Request for quotations through Government e-Marketplace (GeM) for the Procurement of Agriculture Spray Pump for biopesticides application for productivity enhancement in the ESIP areas of Madhya Pradesh and Chhattisgarh as per following details:

- 3. Eligible firms are invited to submit your price quotation through GeM for procurement of agriculture spray pump (ASPEE Brand) for biopesticides application by the local community of project areas of Madhya Pradesh and Chhattisgarh alongwith sample of the agriculture spray pump as per specifications mentioned in Para 2.
- 4. Quoted price will be evaluated and contract will be awarded to the responsive firm offering the lowest evaluated rate as per the specification.

- 5. The deadline for receipt of quotation at the address indicated above is 10 March 2023 by 05:00 PM.
- 6. The prices should be quoted in Indian Rupees and should be inclusive of all taxes (GST). No price increase will be allowed after the submission of Quotations.
- 7. Validity of the Offer: Quotation shall be valid for a period of 90 days from the date for receipt of quotation(s) indicated in Para 5 above.
- 8. Evaluation of Quotations: The procurement committee, ESIP-PIU, ICFRE will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed; and conform to the terms and conditions, and specifications of the RFQ. The firm has to produce a sample of the agriculture spray pump, to be vetted by the procurement committee of the ESIP, ICFRE. The delivery has to be made as per the vetted item only and any deviation will be treated as breach of contract and liable for scrapping of order.
- 9. Award of contract: The contract for the above item will be awarded to the firm whose quotation has been determined to be substantially responsive and who has offered the lowest price as per the specifications of the item.
- 10. Notwithstanding the above, the ICFRE reserves the right to accept or reject any quotations and to cancel the procurement process and reject all quotations at any time prior to the award of contract.
- 11. The Firm whose quotation is accepted will be notified for the award of contract by the ICFRE prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 12. All prices should be quoted F.O.R. destination inclusive of all taxes and contingent costs including, customs packing and forwarding, transportation, handling and insurance etc.
- 13. Standards: The item supplied under the contract shall conform the standard prescribed/specification mentioned there, against the goods in the financial bid.
- 14. Penalty: Supply of non original/similar looking items or items in damaged conditions shall not be accepted. Penalty up to 25% of the value of the supply order may be imposed if items is not provided in specified quality specification and item condition. In addition, the contract will be cancelled and contractor may be blacklisted. However, no penalty will be imposed if the delay in supply occurs on account of intimation by ICFRE for any administrative or logistics contingency.

- 16. The firm will also have to provide literature (in Hindi) related to Agricultural Spray Pumps for the convenience of the farmers.
- 17. The ICFRE shall have the right to purchase the material in full or part thereof, at the risk and cost of the firm, in case firm fails to supply the allocated or indented quantity within the specified time and as per the provided date sheet.

- 18. Notification of Dispatch: In regard to each and every consignment notification shall be made to the ICFRE immediately on dispatch indicating full details of quantity of material so that the ICFRE's concerned officer may plan for storing and distribution of the material.
- 19. The ICFRE shall have the sole and unfettered discretion to decrease/increase the purchase from the firm depending upon market condition and climatic conditions within the validity of the contract.
- 20. Scope of Procurement: Invites price quotations for procurement of the Agricultural Spray Pump as described in the Para 2 of RFQ. The successful Firm will be expected to complete the delivery in all aspects within due time.
- 21. Eligibility to Quote: Firms duly registered with tax authorities may be eligible to participate only if they also:
  - a. Submit proof of registration with the Income Tax Department and Sales Tax Department/GST with the quotation. (Failure to enclose these documents would result in rejection of quotation).
  - b. Submit only one quotation, either individually, or as a partner in a joint venture. All quotations submitted in violation of this rule shall be rejected. Partners in a joint venture shall be jointly and severally liable for the execution of the contract.
- 22. Qualification of the Firm: To qualify for award of the Contract, a firm shall meet the following minimum qualifying criteria:
  - a. As manufacturer/supplier/distributor/authorize representative must have at least three years of experience in manufacturing/supplying/distributing and sale of the Agricultural Spray Pumps mentioned in Para 2. Proof of same may be provided.
  - b. Authorized Dealership Certificate must be provided with the quotation.
- 23. Documents Comprising the Quotation: The quotation submitted by the Firm must comprise of following documents:
  - a. Qualification and experience information and other relevant documents
  - b. Copies of registration/taxation documents
  - c. Certificate of authorized dealership
  - d. Unit Price of the Agricultural Spray Pumps including FOR
  - e. Firm has to present a declaration document of not having blacklisted in any government department/organization.
- 24. Currency of Quotations:
  - a. Rate inclusive of GST shall be quoted in Indian Rupees.
- 25. The rates and prices quoted by the Firm shall be fixed for the duration of the Contract and shall not be subject to any adjustment on any account.
- 26. Delivery period: within 30 days from the date of issue of Supply Order.
- 27. Payment shall be made after successful delivery of the items as per specification.

1. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises vill be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
